Course Summary

The **Three-Year Bachelor's Degree in Employment Consultant and Security Expert** offers students **solid theory and practical professional training** aligned with today's career paths.

The program prepares graduates to work confidently across labour, private, public and economic law, with a special focus on **consultancy** and hands-on skills in **personnel management** for small, medium and large companies. It also builds proficiency in a second European language and advanced digital tools.

Students complete internships and placements with public and private bodies, national and international companies, INAIL, INPS, Courts, professionals, employment consultants, and investigation agencies, gaining **real-world experience** and the **skills** employers value.



Why Siracusa?

Cradle of the ancient Magna Graecia and central figure in Sicilian history, **Siracusa** welcomes its students with the briny scent of the Mediterranean Sea and the marble glow of its monuments. Studying in Siracusa is **more than an academic experience**. It is **nourishment** for the soul, a profound connection with nature, history, and the warmth of the Sicilian people. Classes take place at the **Siracusa Campus, located at Via Sebastiano Agati 10**. Students benefit from the initiatives and research activities promoted by the **International Institute for Criminal Justice and Human Rights**, the campus's main scientific partner.

Course Contents

The Employment Consultant and Security Expert curriculum trains professionals to work confidently in labour law, especially in consulting and personnel management for small, medium, and large companies.

The employment consultants provide **assistance, representation and consultancy**, as well as **managerial support** for the company. They can intervene across key areas of business operations: from recruitment and training to workplace hygiene and prevention; from cost analysis to production planning; from tax and fiscal assistance to bookkeeping. Their expertise may cover the entire **employment cycle**: not only its definition and development, but also all related accounting, economic, legal, insurance, welfare and social aspects. They also assist and represent businesses in any disputes, for example, of a tax nature, or in out-of-court matters, initiating conciliation and arbitration arising from employment relationships, both dependent and self-employed. They may also offer technical consultancy to the court, to parties, and on corporate relations (contracts, agreements, etc.).

The curriculum and teaching content are designed in close synergy with **professional associations of labour consultants**, with which memoranda of understanding have been signed to develop joint training activities and to facilitate young people's entry into the job market.



International Projects

Law students from the University of Messina may apply for a wide range of **international projects and scholarships**, enriching their academic journeys with invaluable global experience. Opportunities include:

- International Exchange Program (Erasmus)
- "Antonino Giuffrè" scholarships for thesis research in extra-EU countries
- Double Italian-Spanish degree
- Foreign languages modules taught by distinguished visiting professors

Career Planning

Graduates can pursue careers either as **employees or independent professionals** within the public and private legal-administrative sectors. Potential workplaces include public administrations, companies, non-profit organisations and international institutions. They may work as civil servants, regional or public body officials, corporate legal advisors, or collaborators supporting various legal professionals.

In particular, employment consultants manage the entire **employment relationship cycle**, from recruitment to assisting companies in both judicial and extrajudicial matters.

The UniME Bachelor's degree in Employment Consultant and Security Expert is the only one provided in Sicily. Our students' results speak for themselves: **over 80%** of graduates have passed the professional licensing exam, with assessments far above the national average.
